"Litigation Over Estate Plans & Intra Family Challenges"

In April we will have local attorney litigator **Barbara Jagiello**, **Esq**. speak to us. The right of self-determination to spend money and give property in any legal manner can be seriously impacted by unscrupulous persons who manipulate and exploit the elderly. This presentation on litigation over estate plans looks to the issues which the courts will consider when it is alleged that someone has taken advantage of an elder or dependent adult to obtain more of their estate than what would otherwise have been given to Manipulation of an elder for personal gain is more frequently described in terms of elder abuse. Thus, the presentation will include a look at the nature of elder abuse, the manipulation of the vulnerability of elders, and issues of dementia. The ease, potential gain and the low risk of exposure attract many to work to overcome an elder's true wishes. Abuse for financial gain results in what is logically described as undue influence which is the inappropriate manipulation through psychological means to gain access to the elder's assets. The presentation will also address what those working in the estate planning field can do to limit the risk of undue influence, legal safeguards, and remedies.

Barbara Jagiello is a San Francisco attorney with 30 years of experience in civil litigation and has handled numerous cases concerning elder abuse, undue influence, and fraud and competency issues. In 1999, she was a California Lawyer of the Year and in January 2000 she was in the feature

or call Bonni at: **925.686.4819** article in the *California Lawyer* entitled *Guardian Angel* which recounted Ms. Jagiello's work in uncovering "the biggest elder-care scandal to ever hit the state." In that case, it was a private professional fiduciary who stole over \$1.6 million from the elder and dependent adults in her care. As a result, the fiduciary and her attorney were sentenced to 26 and 16 year prison terms, respectively.

Ms. Jagiello is a graduate of Yale Law School as well as the University of Southern California. She has been a keynote speaker for the annual meeting of the Professional Fiduciaries Association of California and has appeared as a guest speaker at law enforcement conferences, and other organizations.
