

“Determining Capacity, Legally and Medically”

Join us for a special presentation on March 20th on the topic of “Determining Capacity, Legally and Medically”, presented by Ms. Wendy Greenberg and Dr. Eric Widera. In this presentation, Ms. Greenberg and Dr. Widera will discuss the impact that neurodegenerative diseases such as Alzheimer’s have on decisional capacity and outline practical ways for professionals to assess for impairments in cognitive function and capacity. They will also discuss new approaches to prepare older adults for the potential loss of capacity through advance care planning tools.

Ms. Greenberg is Counsel in the Estate Planning group at Folger Levin LLP. Ms. Greenberg is a member of the Bar Association of San Francisco, the Trusts and Estates Section of the California Bar Association, and the Society of Trust and Estate Practitioners. Ms. Greenberg received her Juris Doctorate from the University of San Francisco School of Law in 1998, where she served as a member of the University of San Francisco Law Review, and her Bachelor of Arts from the University of California at Santa Barbara in 1995.

Dr. Eric Widera is a Associate Professor of Medicine in the Division of Geriatrics at the University of California San Francisco (UCSF). His goals are to improve the care provided to elderly patients with severe chronic and/or terminal conditions through program development and educational innovations. Eric accomplishes this through various leadership roles, including Director of the Hospice & Palliative Care Service at the San Francisco VA Medical Center and Program Director for the Geriatrics Fellowship at UCSF. Eric has been the recipient of numerous grants and awards including a Geriatric Academic Career Award (GACA), the Hastings Center Cunniff-Dixon Physician Award, and the Hartford Foundation as a Center of Excellence Faculty Scholar award.
