Tim will discuss several important ATRA-related issues including the possibility that clients won't need the A/B trust format for estates of less than \$10.5 million and how best to plan for the death of a surviving spouse when there are second marriages and blended families.

"The ABC's of Modifying Existing Plans in a Post-ATRA Environment"

Tim will be discussing the need for review of existing estate plans in the post-ATRA environment which "permanently" perpetuates 2012 exemption amounts. During the discussion, we will consider the consequences of portability and the step-up in basis relative to trust structures commonly in use. Tim will also address formula funding clauses; the use of disclaimers, and simple amendments to existing trusts versus amendments and restatements.

Timothy H. Smallsreed is a partner in the Trusts & Estates and Business practice groups at Wendel, Rosen, Black & Dean LLP. In the course of the estate planning process, Tim frequently handles issues related to business succession planning, including formation of
